Principal Investigator (2001 – 2013) of a series of six studies and a multi-year evaluation of county-level initiatives to expand access to care for the medically underserved. Designed and directed two 58-county surveys and developed multi-county case studies to assess existing and proposed programs to expand services and insurance coverage for uninsured Californians. Designed and directed an evaluation of the California HealthCare Foundation's Step-by-Step: Local Coverage Expansion Initiative, a four-year evaluation of 30 county-based insurance coverage expansions, laying the foundation for health care reform. Methods included an online survey of grantee initiatives, including changes in enrollment and funding secured. Recently completed a five-county study to expand local health care safety net integration and a primer describing the financial impact of state and federal health care reform on community clinics. Key decision makers in foundations and officials at local agencies used study findings to address gaps in county capacity, in areas such as technical expertise. For example, the California HealthCare Foundation developed a four-year grant program, using the findings, to support agencies in 30 counties to plan and/or implement insurance programs for uninsured children and adults, such as "Healthy Kids." Presented findings at state and national conferences. Given written coverage in issues briefs and nationally recognized journals, including the Journal of Health Care for the Poor and Underserved and Health Affairs.

Principal Investigator (2002 – 2010) of an eight-year, mixed-methods evaluation of 19 California clinic consortia funded by The California Endowment to expand their advocacy capacity and provide operational assistance to over 800 primary care clinics in California. Directed all the components of one of the first evaluations to focus on increased capacity by local and statewide clinic associations to advocate and achieve policy gains on behalf of clinics and their target populations, such as maintaining clinic Medicaid funding. Developed a mixed-method design, qualitative and quantitative data collection instruments, and analytical procedures. Created a grantee/funder/evaluator partnership approach whereby evaluation findings contribute to advocacy planning and implementation. Presented evaluation findings at the American Public Health Association, the Western Political Science Association, and the American Evaluation Association. Findings were published in the *Journal of Health Communication* and *The Foundation Review*.

Principal Investigator (2003 – 2006) of two evaluations of Federal grants to expand clinic use of information technology in Northern California, funded under Federal Community Action Project (HCAP) grants: (I) a 3-year evaluation to assess an integrated approach to diabetes care management in rural clinics in Northern California, and (2) a 3-year evaluation of an integrated approach to behavioral health services in rural California with expansion of IT and telemedicine clinic capacity. Combined survey tools and secondary data analysis, including a pre/post partnership survey and aggregate analysis of clinic diabetes registry data. Both evaluations provided key data on opportunities for advancing clinic adoption of IT, such as upgraded clinic computing capacity.

Evaluation Consultant (2012 – 2015) for the VA Centers of Excellence in Primary Care Education, a 5-site demonstration program to develop and test new educational approaches and models of collaboration between different health care professionals related to patient-centered clinical practice. The evaluation is intended to characterize site educational and clinical redesigns, as well as assess the impacts of the program on trainees, patients, and VA facilities.
